The activity and the required personal data are detailed in the application form.
- 1.2 Whether or not you provide your personal data to the CIC is voluntary. However, where you are providing information for the purpose of an application, it is necessary that you supply the CIC with complete information as specified on the application form. Otherwise, the CIC may be unable to process or consider your application. If you are under the age of 18, you should consult your parent or quardian before providing any personal data to us.
- 1.3 You are entitled to request access to and correction of any errors in your personal data. 2. Purposes of Collection

Your personal data will be kept confidential and may be used by the CIC for the following
